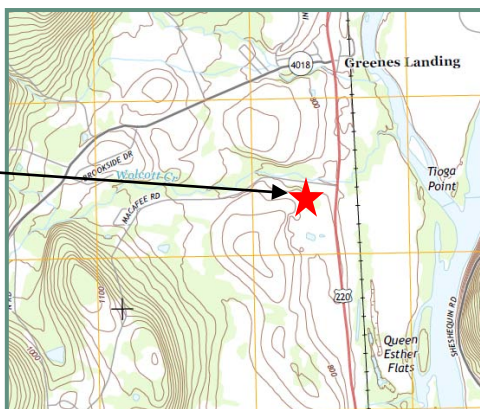

### **Infrastructure (Water & Sewer):**

Athens Municipal Authority provides public sewer services and Aqua Pennsylvania provides public water service. The Authority currently has limited excess sewer conveyance and collection capacity. Water and sewer run along State Route 220.

### **Site Access:**

Site access is off State Route 220 to the east of the property.

### **Existing Terrain:**

The property includes a flat, open field with slopes ranging from 0-8%. Currently, this location is used as an asphalt/gravel plant. The soils in this area are very diverse including; Rexford silt loam, Unadilla silt loam, Braceville silt loam, and Alton gravelly sandy loam.

### **Railroad Availability:**

No, there is not railroad access to this site.

### **Floodplain Regions:**

The site is not located within 100-year floodplain region.

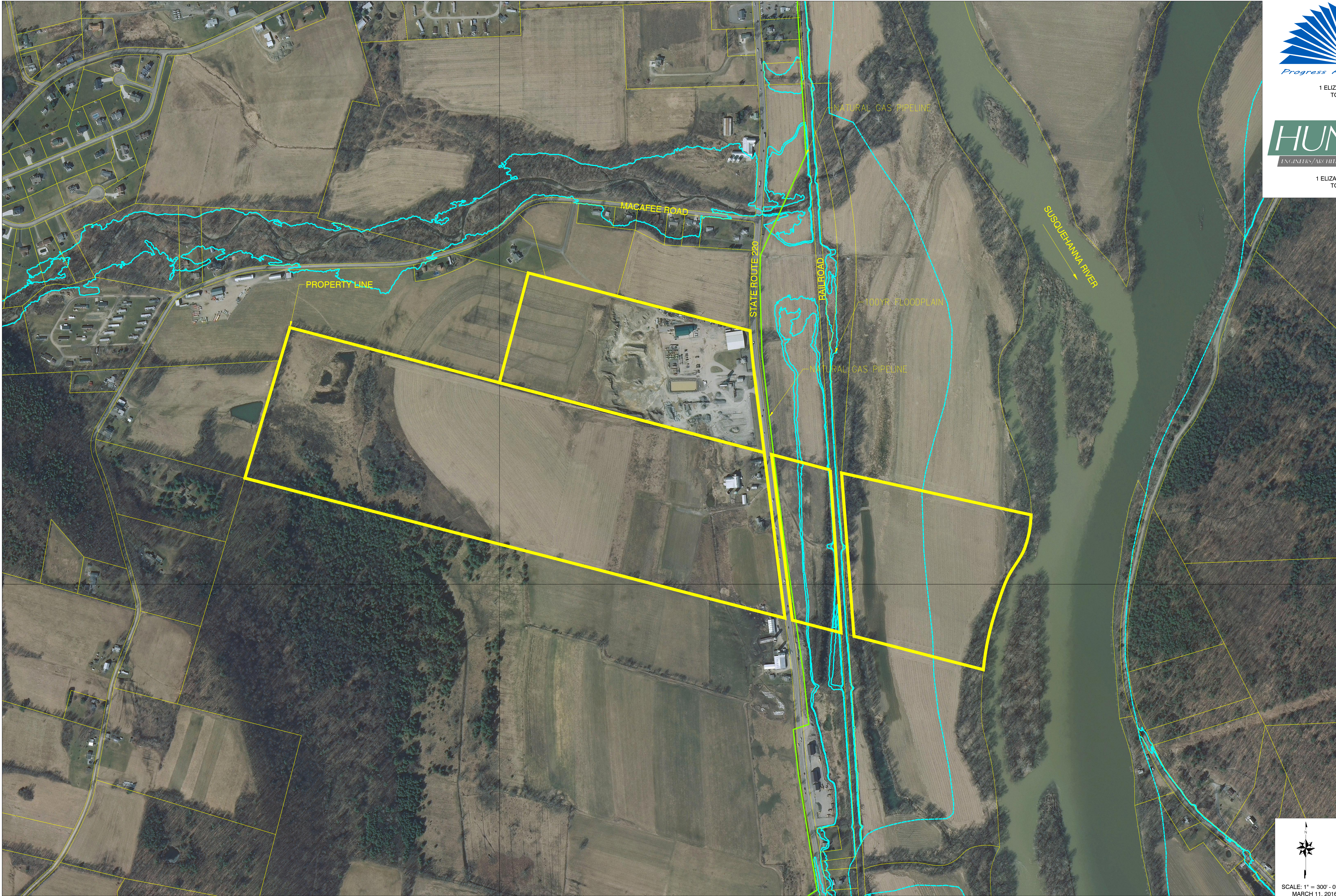

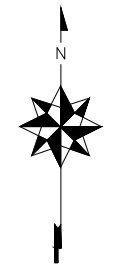
