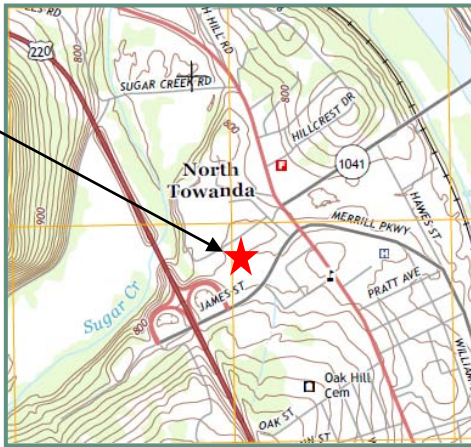

Infrastructure (Water & Sewer):

Towanda Municipal Authority operates the public water supply and wastewater treatment. The Authority currently has excess conveyance and collection capacity within both the water and sewer systems. Water and sewer is available off State Route 6 (SR 6), adjacent to the eastern side of the property.

Site Access:

Existing access to the site is off Patterson Boulevard which leads to State Route 220, this access is located on the southeast side of the property. Additional access points are available on east side of the property off Race Street.

Existing Terrain:

The site is relatively flat with slopes ranging from 0-8%. The property is currently an industrial facility commonly known for printed circuit board manufacturing. Site features include, buildings, impervious parking lots, industrial wwtp and lawn/landscaping areas. Soils at the site are primarily Volusia channery silt loams and Pope soils.

Railroad Availability:

There is no railroad access to the site.

Floodplain Regions:

A majority of the site is located within the 100-year floodplain, Zone AE.

Based on existing mapping, the property has no identified potential wetlands on-site.

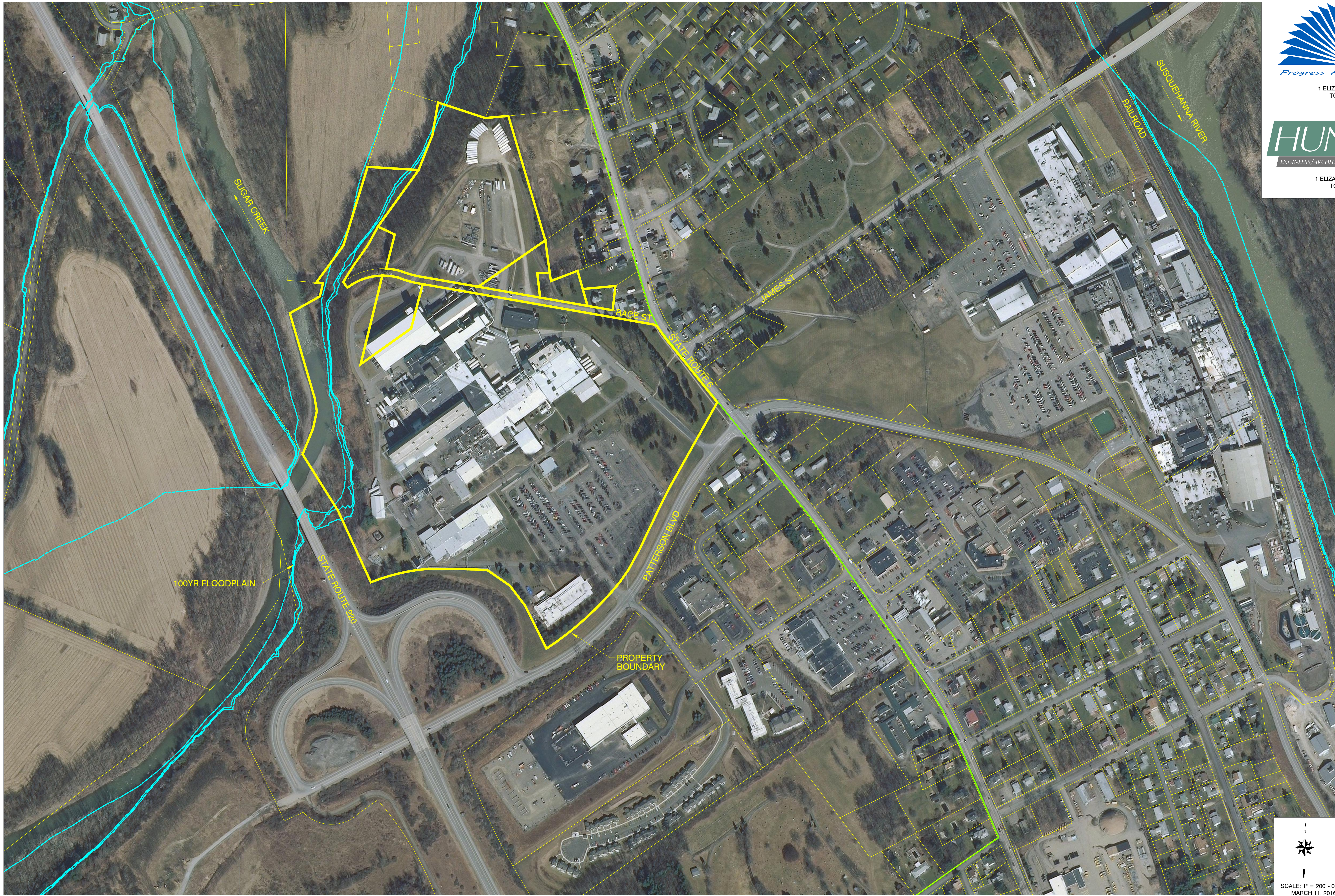
An existing 4 inch natural gas pipeline owned by Valley Energy runs adjacent to the site along State Route 6 (SR6) to the east of the property.

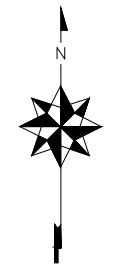

NOTES TO USERS

Coastal Base Flood Elevations shown on this map apply only landward of 0.0' North American Vertical Datum of 1988 (NAVD 88). Users of this FIRM should be aware that coastal flood elevations are also provided in the Summary of Stillwater Elevations tables in the Flood Insurance Study report for this jurisdiction. Elevations shown in the Summary of Stillwater Elevations table should be used for construction and/or floodplain management purposes when they are higher than the elevations shown on this FIRM.

Boundaries of the **floodways** were computed at cross sections and interpolated between cross sections. The floodways were based on hydraulic considerations with regard to requirements of the National Flood Insurance Program. Floodway widths and other pertinent floodway data are provided in the Flood Insurance Study report for this jurisdiction.

Certain areas not in Special Flood Hazard Areas may be protected by **flood control structures**. Refer to Section 2.4 "Flood Protection Measures" of the Flood Insurance Study report for information on flood control structures for this jurisdiction.

The **projection** used in the preparation of this map was Pennsylvania State Plane north zone (FIPZONE 3701). The **horizontal datum** was NAD 83, GRS80 spheroid. Differences in datum, spheroid, projection or State Plane zones used in the production of FIRMs for adjacent jurisdictions may result in slight positional differences in map features across jurisdiction boundaries. These differences do not affect the accuracy of the FIRM.

Flood elevations on this map are referenced to the North American Vertical Datum of 1988. These flood elevations must be compared to structure and ground elevations referenced to the same **vertical datum**. The Special Flood Hazard Area is the area subject to flooding by the 1% annual chance flood. Areas of Special Flood Hazard include Zones A, AE, AH, AO, AR, A99, V, and VE. The Base Flood Elevation is the water-surface elevation of the 1% annual chance flood.

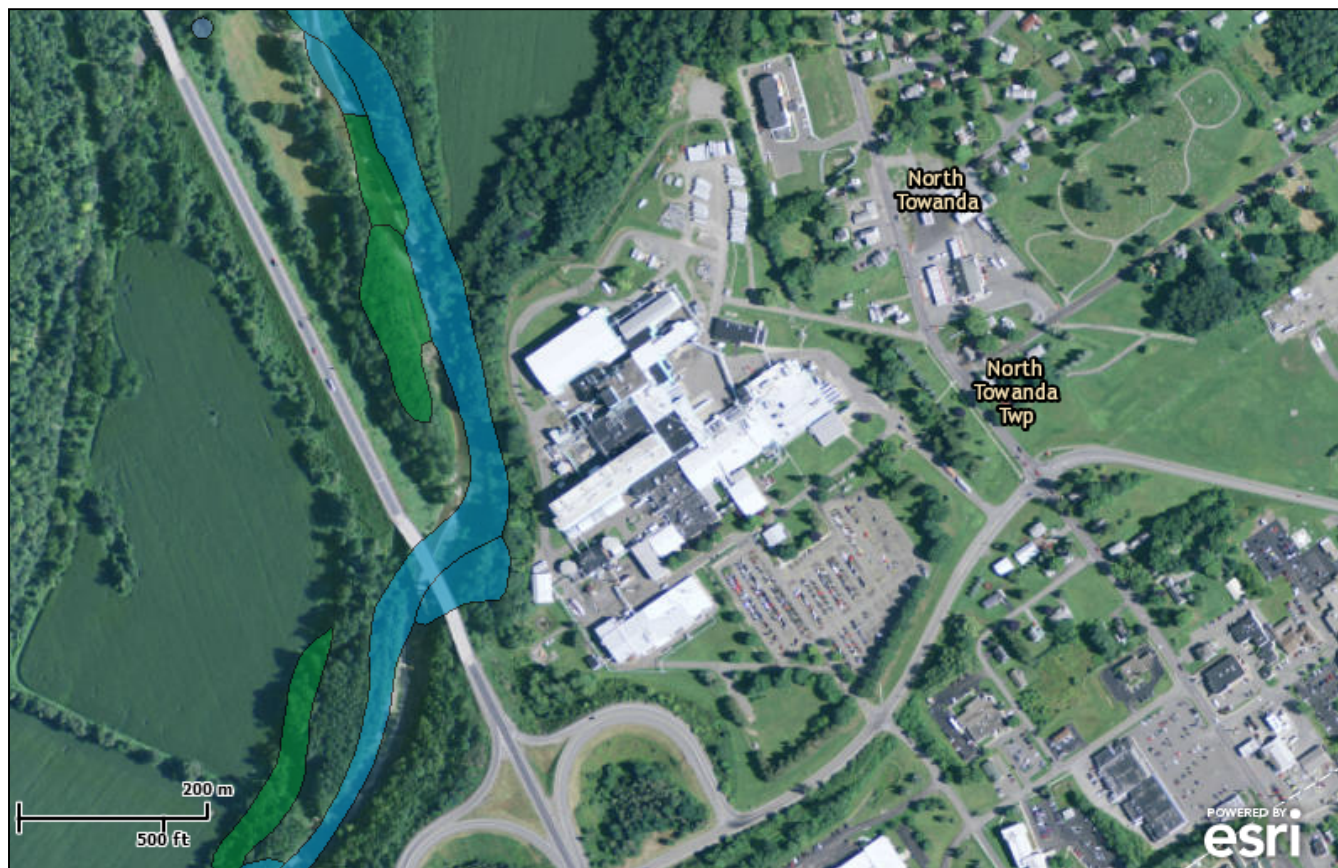

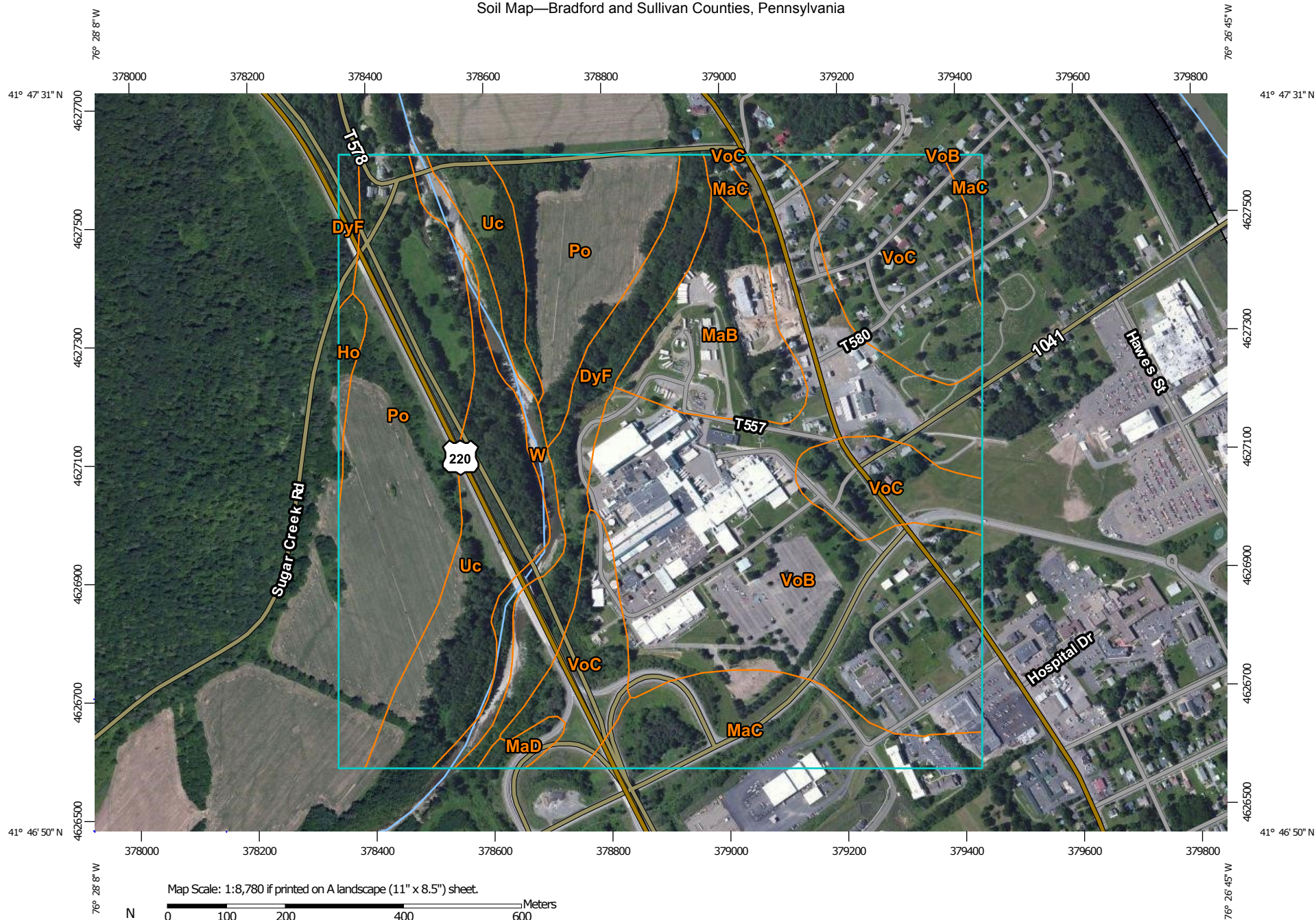

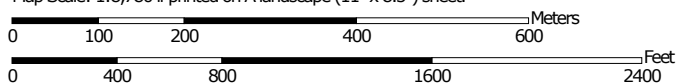
