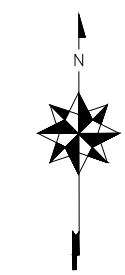
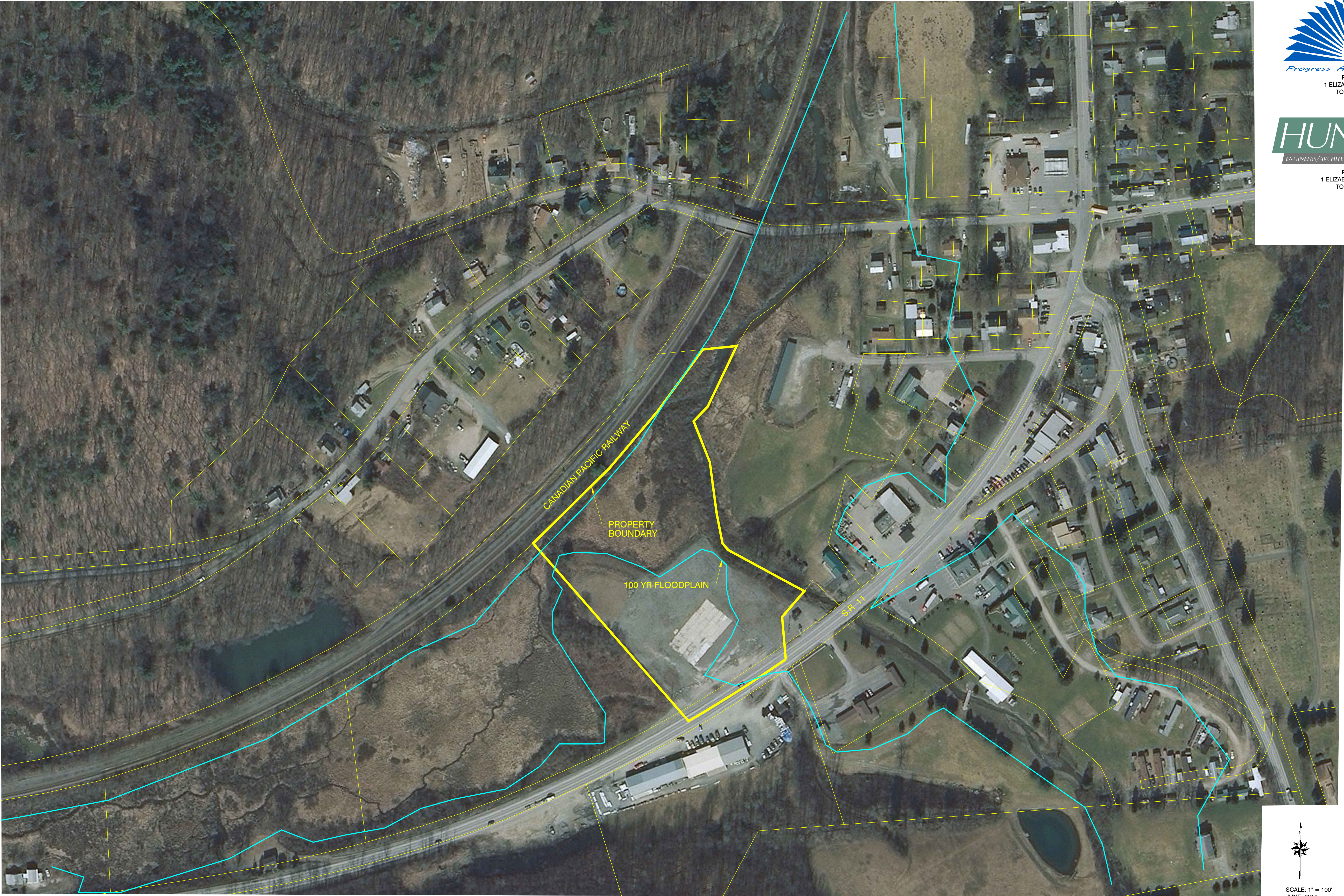

NOTES TO USERS

The **projection** used in the preparation of this map was Pennsylvania State Plane, north zone (FIPSZONE 3701). The **horizontal datum** was NAD 83, GRS80 spheroid. Differences in datum, spheroid, projection or UTM zones used in the production of FIRMs for adjacent jurisdictions may result in slight positional differences in map features across jurisdiction boundaries. These differences do not affect the accuracy of this FIRM.
